# RIPE Database Usage Survey: Open-ended responses overview The RIPE Database Requirements Task Force, March 2020

In total, 206 respondents answered the RIPE Database usage survey from January 2020.

There were six questions in the survey. Question 5 and Question 6 were open-ended questions where respondents could mention two things they liked and two things they disliked about the RIPE Database.

We compiled all of the comments for both questions and categorised the answers. We also added a percentage rate per category to better understand what the most frequent comments were. We also added two annexes that are comparing results from closed Questions 1-4 with Question 5 (Annex I) and Question 6 (Annex II).

Due to rounding, percentages may not always appear to add up to 100%. For multiple-choice questions, the total number of answer choices selected for a question can be greater than the number of respondents that answered the question. This can cause the total response percentages to exceed 100%.
